

Each European National Federation is invited to enter a team in each of the disciplines of Dressage, Jumping and Eventing. Athletes are invited through their National Federation.

The Championships are open to athletes from the beginning of the year in which they reach the age of 12 years until the end of the year they reach the age of 16 years.

Ponies must be 6 years or older.

Individuals instead of teams :

A national federation, which cannot send a complete team, may send per discipline one or two individuals with one pony each.

Dressage Championships :

Each National Federation may enter one team of not more than five athletes and five ponies of which four athletes and four ponies are allowed to travel to the Championships and four to start in the team Championships.

Jumping Championships :

Each National federation may enter one team of not more than six athletes and six ponies from which five athletes and five ponies are allowed to travel to the Championships and four to start in the team Championships.

Eventing Championships :

Each National federation may enter one team of not more than four athletes and four ponies from which, in regard to Individuals and in addition to teams, four to start in the team Championships. Teams of three are allowed. Art. 510.2 and Annex 12 Art P11 of the Eventing Rules.

Grooms :

CH-EU-Ch : Each National Federation is entitled to send one groom for each two ponies with a maximum of two grooms per team. CSIP : Maximum 1 groom per rider. For eventing: max. 3 grooms per team

Athletes from foreign NF's : Each nation is allowed to send 4 athletes to the CSIP.

All ponies will be measured before being allowed to start and NFs are responsible for ensuring that they are in compliance with FEI rules. All ponies must be at least 6 years old. + Art. 3111 of Vet Regulations

ONLY FOR JUMPING

Permitted Bits for Ponies in Jumping

Approved by the FEI Bureau on 15 April 2010 for safety reasons, effective immediately

The rules governing the bits permitted to be used at Pony Jumping events (Appendix A to Annex XV of the Jumping Rules) have been modified as follows:

1. Bits. The following types of bits are allowed. Bits can be made of any material (metal, rubber, plastic, leather...) but must be used in the original manufactured state. Double bridles are not allowed. The minimum diameter of the bit shall be 10mm.

**All snaffles: jointed, double jointed or unjointed
 myler
 soft twisted**

**All gags: normal snaffle gag, jointed or unjointed
NB: No wire, double wire, or chain bits may be used.**

**All pelhams: jointed, double jointed or unjointed
 soft twisted
 Cheeks maximum length 15cm**

NB: All pelhams must be used with one single rein. The rein must either be used with a connecting strap or attached to the larger of the two rings of the bit.

All kimberwicks

All peassoas: **maximum 3 rings**
 jointed, double jointed or unjointed
 Cheeks, maximum length 16cm

Hackamore: Cheeks may not exceed 17cm

NB: No hackamore may be used in combination with a bit.

The time and date of arrival of athletes and horses and their means of transport must be given to the Organising Committee on the entry form, to facilitate them on arrival. All ponies are to be on the showground before 17.00 h on Monday 26 July 2010.

5. ADVERTISING AND PUBLICITY ON ATHLETES AND HORSES (Art. 135)

The athletes are authorised to carry their "LOGO" of their personal sponsor on the saddle cloth in accordance with Art 136. The Chief Steward will check that the advertising and publicity on Athletes and horses complies with Article 136 of the General Regulations.

The Chief Steward is responsible for ensuring that FEI regulations relating to Art. 135 are respected by athletes before entering the arena. Athletes not complying with Art. 135 will not be permitted to enter the arena during the competition.

The athletes must take part in the prize giving ceremony on the pony they started in the corresponding competition. The first 10 athletes of the class must present themselves in the prize giving ceremony.

3. INSURANCES

The OC and its commissioners are not responsible for damages done to property, persons and fortune, caused by accidents and malady of athletes, ponies and stable staff.

Damages on coaches, harnesses, saddlery, stable utensils and all other objects (including damages of theft, fire) or other incidents are not under responsibility of the OC and its commissioners.

All owners and athletes are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horse. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

5. EVENT'S ORGANISATION (Art. 110.2)

In exceptional circumstances together with the approval of the Ground Jury the OC reserves the right to modify the schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances. 8. ENTRY RIGHT TO SHOWGROUNDS (Art. 133, 1005)

Individual athletes with two companions (according to the FEI-General Reg), all grooms, chefs d'équipe and official staff confirmed by the national federations. These show passes allow access all over the show ground. Only those with correct authorisation will be able to access the stabling area.

The use of all motorized vehicles, including motorcycles, mopeds and quad bikes on the showground, cross country course and near the stables is strictly prohibited. Only bicycles may be used.

9. SCHOOLING DURING COMPETITIONS

Training areas with practice obstacles are on the show grounds at the athletes' disposal. No riding is allowed outside these dimensions of training areas. Schooling hours on the paddocks or main ring are timetabled in the time between 1 hour before the first class and half an hour after the last class. The training schedule will be published at the Show Office.

THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

STABLE SECURITY/STEWARDING AT INTERNATIONAL EVENTS
Minimum requirements to ensure implementation of Veterinary
Regulations, Art.1005.2
See also Annex XIII of Eventing Rules

1. ACCESS TO STABLE AREA

For an optimal stable security, the stables must be completely enclosed within a suitably restrictive perimeter (stable area) which will act both as a deterrent to the admission of unauthorised persons and to the exit of horses. The area must be sufficiently large to allow horses to be evacuated from the stables in an emergency but still remain within the confines of the perimeter. However, several disciplines allow in specific situations a lower level of stable security (see discipline rules).

Whenever possible the stable area must include only stables; lorries, caravans, etc., should not be permitted within the area unless specifically needed as accommodation for horses and/or grooms.

Access to stables must be limited to those persons indicated in VRs Art. 1005.2.5.2. It is essential that the official issuing authorised access be a responsible person of seniority within the OC.

2. CONTROL OF ACCESS

A control system must operate at all entrance gates so that there is an efficient and reliable method of identifying those who enter and leave the stable area at any time.

Extra vigilance must be used in establishing the identity of persons and reasons for entering the stables during the night.

3. STEWARDING OF STABLE AREA

At least one stable steward, directly responsible to the Chief Steward, must be present or readily available in the vicinity of the stable area 24 hours a day during the entire duration of the event. He may be assisted by deputies as required. The steward/deputies must regularly patrol the stable area, without establishing any predetermined pattern, to discourage any form of illegal practices or abuses to horses. Any misdemeanours must be reported immediately to the stable steward who must, in turn, report to the Chief Steward.

The duty of the stewards is therefore to safeguard the welfare of the horses and to prevent any form of illegal practices.

4. GROOMS

It is appreciated that grooms wish to remain with their horses during the night. Only grooms duly registered with the OC are permitted to do so.

The Person Responsible must ensure that his/her grooms, or any other authorised persons with access to his/her horses, are familiar with the security and stewarding procedures operating at the event attended.

5. MOVEMENT THROUGHOUT EVENT GROUNDS

Movement of horses between the stables, practice, grazing and main arena must be strictly controlled. The optimum layout for Jumping and Dressage disciplines is attached. It is appreciated that flexibility will be required depending on the requirements of other disciplines.

6. STEWARDING OF PRACTICE ARENA

The Chief Steward must ensure that all practice arenas are adequately stewarded all the time that they are officially open. He must also ensure that these arenas are subject to random control when they are officially closed.

7. GRAZING AREA

It is recommended that a grazing area be provided at all outdoor events, and that this be subject to random control. If available, horses must only be grazed or walked in hand within this area. The Foreign Judge/TD at events will be specifically asked to check that the relevant requirements are met as reasonably as can be expected, depending on the discipline, and to indicate clearly any shortfalls, following which consideration may be given to altering the category of the event in future.
